### ADVOCACY & POLICY

- Membership Increase Discussion:
- 1. What if a member renews with NAEA and then their home state goes independent from NAEA? Will they get refunded their full membership?
  - In this case we will refund the member directly for the difference they paid in state vs national dues. We also contact them and encourage them to visit the state association's website directly to renew.
- 2. What would be the NAEA membership rates for Rhode Island to join if RIAEA was independent from NAEA?
  - If RIAEA's membership is no longer connected to NAEA's, the rates would be:
  - Active Professional: \$105
  - Associate: \$105Retired: \$50
  - Early Career: \$95Preservice: \$40
  - Preservice: \$40Institutional: \$225

Also, please note that since our fiscal year is over in less than two weeks, and all the rates and pre-printed forms have already updated with the dues rates, we are unable to modify dues contracts until July 1, 2026.

  - RIAEA dues contracts have already been filed for the next fiscal year. We will be eligible to separate from NAEA for the following fiscal year and update dues contracts on 7/1/2026
